In consideration for permitting Exhibitor to participate as an Exhibitor in the FAYETTE COUNTY’S TOAST TO SUMMER 2020 (the “Event”) as directed by the relevant staff, the undersigned, for themselves, and for their respective heirs, personal representatives and assigns, agrees as follows:

Release and Waiver: The undersigned hereby RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE Fayette County’s Toast to Summer 2020, Fayette County Pilot’s Association, Fayette County Commissioners, and each of them, their officers and employees, (collectively, the “Releasees”), from and for any liability resulting from any personal injury, accident or illness (including death), and/or property loss, however caused, arising from, or in any way related to, Exhibitor’s participation in the Event, except for those caused by the willful misconduct, gross negligence or intentional torts of the above parties, as applicable.
